Moved by Cain and seconded by J. Barclay to approve the purchase a \$500 sprayer from Bomgaars for the lagoons. All members present voted aye. Motion carried.

Discussion was held regarding the purchase of a portable lift for the village truck. Maintenance to obtain more information. Topic tabled until next meeting.

Moved by Cain and seconded by J. Barclay to purchase new tires for the skid loader pending price. Maintenance is to obtain three estimates and go with the lowest cost. All members present voted aye. Motion carried.

The board reviewed security camera estimates from Midwest Alarm. Discussion followed, with the topic tabled.

Moved by Cain and seconded by Utemark to renew lease with Loffler for office equipment. All members present voted aye. Motion carried.

There were citizen concerns regarding dangerous driving on North Street. Citizen would like to see North Street closed.

There were no board reports.

Maintenance supervisor report- Bruce gave an update on networking, water samples, town maintenance, etc.

Clerk report- Sam gave an update on FY reconciliation for the budget, applications for the open maintenance position, and the little free library status.
